The Department of Transportation's (DOT) mission to ensure a fast, safe, efficient, accessible, and convenient transportation system depends on proper stewardship of funds and effective enforcement of laws and regulations. The Office of Inspector General (OIG) plays a crucial role in fulfilling DOT's mission by detecting and preventing waste, fraud, abuse, and mismanagement. In order for our office to fulfill this role, it is necessary that Operating Administrations notify us whenever circumstances appear to indicate a potential criminal violation.

However, this notification does not always occur. For example, our 2016 audit of the Federal Railroad Administration's (FRA) oversight of transportation of hazardous materials by rail found that FRA did not refer any potential criminal violations to our office during the 10 years prior to the audit. Given possible weaknesses in the referral process, we are initiating an audit to assess whether DOT and its Operating Administrations have policies and procedures to ensure that potential criminal violations are promptly referred to our office.

We plan to begin the audit this month and will coordinate with your audit liaison to schedule an entrance conference. We will conduct our work at DOT Headquarters and other sites as needed.
